# WITHDRAWAL OF REQUISITION NOTICES

Firetail Resources Limited (ASX: FTL) (**Firetail** or the **Company**) refers to its announcement of 22 July 2022 regarding the receipt of notices under sections 203D and 249D of the Corporations Act 2001 (Cth) (**Notices**) from Japan & China Holdings Australia Pty Ltd and Moray Holdings (QLD) Pty Ltd (together, **Requisitioning Shareholders**).

Firetail is pleased to advise that following productive discussions, the Notices have been withdrawn by the Requisitioning Shareholders. As a consequence of the withdrawal of the Notices, the General Meeting which had been convened to be held at 2.30pm (Perth time) on 16 September 2022, will not proceed.

The Board and the Requisitioning Shareholders have come to a mutually acceptable outcome that enables the Company and the Board to focus fully on value creation.

As a result of these discussions, the Board and the Requisitioning Shareholders have agreed to withdraw the proposed appointment of Warwick Grigor as Non-Executive Director and there will be no change to the Board.

## **Executive Chairman, Brett Grosvenor, commented:**

"The Board is pleased that during the period of engagement with our shareholders, we were able to demonstrate the strength of the current development strategy and the great progress made by our exploration team to date.

"While the past weeks have been a distraction for the Company, we credit our strong team in continuing to deliver on our exploration milestones, and we are very pleased with the recognition of the credentials of our Board in steering the Company.

"We intend to continue to progress our exploration activities with a focus on maximising shareholder returns."

# **Shareholder Paul Byrne of Moray Holdings, commented:**

"We have been reassured by our discussions with the Firetail Board over the past few weeks, and we commend their engagement around the work program and exploration activities that we sought to better understand.

"Through this process we have gained significant comfort with the direction the leadership is progressing the strategy and we remain supportive of the Company moving forward."

#### **Upcoming Exploration News Flow**

The Company is progressing its exploration program at Yalgoo, Dalgaranga and Mt Slopeaway, with the following exploration activities planned:

- Yalgoo
  - Heritage Survey scheduled to start next week
  - Earthmoving for drilling access scheduled for mid-late September
  - Maiden 2000m RC Drilling Campaign scheduled for late September- early October
- Dalgaranga Geochemical Interpretation:
  - Rock chip results from latest mapping campaign geochemical Interpretation for lithium prospectivity




#### **About Firetail Resources**
